



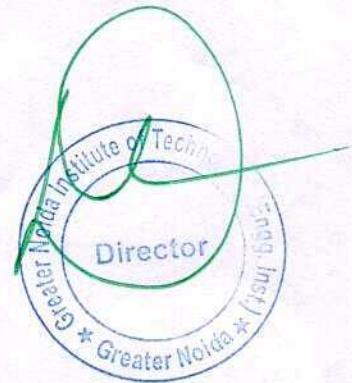

## Sanctioned Posts and Faculty Cadre Ratio

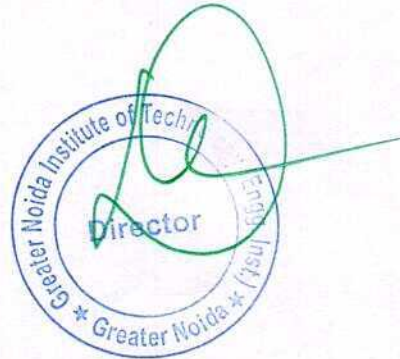
